Minutes of Sutcombe Parish Council Meeting held in the Memorial Hall on Monday 13th September 2021 which commenced at 7.45p.m

1. Chair's announcements

Councillor Chris Quance welcomed all to the meeting.

2. <u>Declarations of Interest</u>

4. <u>Public Comment Session</u>

No Members of the Public present.

5. <u>Reports from Devon County Councillor and District Councillors:</u>

DCC James Morrish reported that not a lot was going on, one of the problems raised at present is to do with the 'Link Project' a secure place where people can go who have mental health issues, the venues in Holsworthy, Bideford, Barnstaple and Braunton have been threatened with closure as funds were being withdrawn. DCC's Argument was that hey were underused, but over the last 18 months no-one could attend du to Covid restrictions, And the lack of officers from DCC.

There is a meeting on the 15th September. To-date I have heard nothing from the Councillors of Holsworthy or Bideford. The present proposal is that finances would be supplied for a Mental health referral unit in Exeter and more care in the Community.

I am still having fun with finance and pensions, and have had 140 emails regarding DCC investments, with concerns Over finances being invested in non-ethical companies.

Finally, James reported that he had recently spoken to Barry Parsons who sends his best wishes.

District Councillor Stephen Harding said that there was not a lot happening in Torridge at present, domestic violence remains a problem and it is hoped to get financial backing to help those affected. There are also problems with the Bucks Mill environmental Pump House, with effluent being pumped into a stream.

Stephen reported that he had missed the last full Council meeting due to a contentious planning application, Councillor Quance commented that he had read several articles regarding 'wily' builders getting away with not building affordable housing as proposed in planning applications, and hopes this will not be the case with the application for residential properties in the field next to the Memorial Hall

The Chair Councillor Chris Quance thanked Councillors for attending and their reports.

6. All members of the Council had received a copy of the minutes of the Parish Council meeting and the Annual Parish Council Meeting (AGM) held on the 12th July 2021 by email, with the unanimous decision of the Councillors, the contents were deemed true and correct and were duly signed by the Chair Councillor Chris Quance
