Minutes of Sutcombe Parish Council Meeting held in the Memorial Hall on Monday 8th November 2021 which commenced at 7.45p.m

1. Chair's announcements

Councillor Chris Quance welcomed all to the meeting.

2. Declarations of Interest

- a) Register of Interest: Councillors are reminded of the need to update their register of interests. *There were none declared*
- b) To declare any personal interests in items on the agenda and their nature. There were none were declared
- c) To declare any disclosable pecuniary interests in items on the agenda and their nature. There were none declared.

3. Apologies and reasons for absence were received from:

PCSO Mark James- not on duty. Parish Councillor H. Rowlands (ill), Devon County Councillor James Morrish

4. Public Comment Session: No Members of the Public present.

5. Reports from Devon County Councillor and District Councillors:

District Councillor Stephen Harding reported that there was a new North Devon beat officer, with the addition of 25 new police officers in the New Year. The new campaign 'Stop speeding' before Christmas is up and running. Some officers are busy with the Leisure Industry, with the Council taking over in April. There had been motions regarding 'Emergency Climate' changes, and sustainable Methane, cows being the worst animals for this, here is a lot more to be sorted regarding this subject.

Councillor Emma Horn commented that there still seemed to be a lot of people on furlough.

The subject of Social Housing was raised, with Councillor Quance commenting that developers must not wriggle out of supplying such housing.

District Councillor Richard Boughton commented that he basically agreed with this, but the problem was that sometimes when planning applications were approved, the developers say it's not financially viable to build affordable houses and then wriggle out of it. It is a big problem. Councillor Quance commented that Torridge Planning must stipulate and then stick to it. Richard went on to report about the proposed Solar Farm at Pyworthy, which was approved by 5 votes to 4, there had been a massive campaign against the site, Bridgerule Council did not complain at all.

The 160 acres of the site consists of 40% grade 3 the rest being 4 and 5, such a waste of land.

Councillor Anna Dart apologised for being late and said she thought Stephen and Richard had said all that was Necessary, but as she had not attended for some time thought she would drop in to see everyone.

The Chair Councillor Chris Quance thanked Councillors for attending and their reports.

6. All members of the Council had received a copy of the minutes of the Parish Council meeting held on the 13th September 2021 by email, the contents were deemed true and correct and were duly signed by the Chair Councillor Chris Quance
