At present it is costing Torridge 1.3 million to house families That have been needing rental properties.

Torridge has a lot 'balls in the air', it is looking at a floating wind farm, a depot is needed for recycle lorries. It was noted that Richard Boughton was not re-elected, the Parish Councillors voiced their disappointment As Richard had always supported the Parish Councillors and his advice was always solid and very helpful, he will be very much missed.
