1) Chairman's announcements

Councillor Stephen Horn welcomed the Parish Clerk back after her recent absence due to a hip operation, The Clerk thanked Stephen and the other Councillors for their good wishes and concern during her recovery.

2) Declarations of Interest

3) Apologies and reasons for absence

Apologies were received from Councillor J Shepherd, District Councillor Ian Parker and County Councillor Barry Parsons

4) Public Comment Session

No members of the public were in attendance.

5) Approval of Minutes

All members of the Council had received a copy of the minutes of the Annual General Meeting and Parish Council meeting held on the 9th May 2016 which were sent to the Clerk by Diane Pool, they were agreed as true and accurate and duly signed by the Chairman Councillor Stephen Horn.

6) Matters Arising

- 1) **Village Benches repairs;** the benches had now been finished and it was noted that an extremely good job had been done by Mr Roger Furse, the benches look very smart and are now in excellent condition
- 2) **Grant Funding for the Play Equipment;** the Chairman Councillor Stephen Horn gave his sincere thanks to Councillors Claire Furse and Barry Galbraith-Marten for their very hard work in completing the application form from Torridge District Council for the Community Grant, the amount requested was £10,000.00, the closing date was the 20th June and a decision should be made by the 18th July 2016.

 Councillor Ken Carroll informed the councillors that Councillor Ian Parker and himself had a budget of £10,000 to award as Grants to the Parishes in their Ward. They can be applied for in parcels of £1,000 £1500, as far as he was aware none of the funds have as yet been allocated. Chairman Councillor Stephen Horn asked Barry and Claire to get an application form from Ken. The Chairman will also complete and application form for the locality grant from Councillor Ian Parker for the Queens 90th Celebrations.
- 3) **School Playing Field;** this is ongoing with County Councillor Barry Parsons, it has been confirmed that no Play equipment that is in the School Playing Field will be removed.
 - The online survey regarding resident s input to what play equipment they would prefer will be completed by The end of June, the current consensus of opinion is that the School Playing field would be the ideal place to erect any new equipment.
 - Councillor Chris Quance informed the Parish Council that Property People had been to look at the School, but it had come to light that the School could not be disposed of as the original owner of the land had given the land in 1874 under a 'school covenant'. The descendants of the original owners must be traced and their permission sought to dispose of the property and grounds. The school will be locked up on the 31st July 2016. A summer fete will be held in the school playing field on the 9th July.
